## **April Field Trip**

On April Fool's Day, seventeen of us went to hunt fossils at the CF Industries Phosphate mine dumps. It was a beautiful day and it was even better when several megs in good condition were found. Some of the finds included three horse teeth, a horse astragulus, ray scutes, dolphin vertebra, fish vertebra, several small shark teeth, some real nice megs, and a small whale tooth. We hope to have another trip there before the really hot weather is upon us. It was hard to be so close to the Peace River and not be able to do a little fossiling, but the water level being about 6 feet above normal precluded even the most daring from giving it a try.

We have a few trips to Ruck's Crystal Mine and several beautiful specimens have been found. The specimens are mostly clams that have exquisite calcite crystals that have grown inside the shell. According to the mine owner, this is the only location in the world where these crystal formations are found. See Mike Siciliano if you would like to sign up for a trip.

Our Pit Trip Director, Gunter Lobish, had been leading trips into the Quality Materials pit where they have been finding some Pleistocene animal bones and teeth as well as sand dollars and urchins. He will have trip sign-up sheets available at the April meeting.

As we know, all fossil hunters are optimistic, and we know the Peace River will someday be low enough so we can set up a Club trip. Perhaps, by late-May!

It's that time of the year when those who like to diving should be ready at a moment's notice to go into the Gulf. See Mike Siciliano, our Dive Trip Director for details.



# Wrapping A Sharks tooth or Wrapping the Triangle

Our technique for making a wire wrapped pendant is described here. The way we modify the technique is that instead of wrapping spiral coils of wire from bottom to top of the shark's tooth or other triangular shape, you would wrap the spiral coils 1/2 way up the triangular shape and then wrap the wire around behind the triangular shape horizontally to the 1/2 way point on the opposite side of the triangle. In the picture at above, you can view how you would begin with the spiral at the bottom (point 1) and continue wrapping the wire to the 1/2 way point, point 2. From point 2 to point 3 in the figure, the wire is essentially horizontal, behind the tooth. At point 3 you change the direction of the wrap to securely hold the top of the shark's tooth and wrap up toward the center of the top of the tooth, point 4. From point 4 to point 5, the wire is wrapped diagonally, behind the shark's tooth. The wrap is completed by wrapping the wire from point 5 to point 6. At point 6 the wire is bent horizontally and wrapped around the middle wire of the spiral, running up the center of the back of the tooth. After this wrap is completed, the excess wire is cut and the cut end is squeezed flat. At this point you would have about 1 1/2" of wire remaining from the central wire in the spiral. This wire is first bent 90 degrees, then a loop is made at the bend and finally the loop is wrapped closed.

# Florida Fossil Permit Application

This application is for a permit that will entitle the person named on the permit to collect, for the period of one (1) year, vertebrate fossils on land owned or leased by the State of Florida. The permittee must abide by all the provisions contained in Florida Statutes § 1004.575-576 and the University of Florida Regulation implementing this law. Persons who already have a permit and wish to renew it for an additional year should not use this form. They should follow these instructions instead.

**Print out and mail completed application to:** Program of Vertebrate Paleontology, Florida Museum of Natural History, University of Florida, Gainesville, Florida 32611-7800, USA

#### The following must be enclosed with the filled-out application:

- 1. Photocopy of applicant's identification document (i.e., driver's license, birth certificate, or passport).
- 2. Check or money order for \$5.00 in U.S. currency payable to the Program of Vertebrate Paleontology. If you are sending two or more applications, just send one check for the total amount, not multiple checks of \$5. **PLEASE DO NOT SEND CASH.**
